For six years after they married they lived near Peach and Brushy Creek in SW Montgomery Co. Later they moved to the old home place on the north side of the old Magnolia-Waller Road just inside the Montgomery Co. line. They built a new home there in 1915. George built a syrup mill on the farm and operated it for years when sugarcane was grown in the area.

I consider the following information to be as accurate as possible. Census records (1850-1920), death certificates, obituaries, birth certificates, pension applications, cemetery records, personal interviews, AAFA records, bible records, family legends, church records, were used extensively for documentation. I would like to increase the data on the children and grandchildren of Samuel Alford, as well as Julius Charles Alford and John Turner Alford, son of William Henry. (10) William Henry Alford, youngest son of Job Alford, was born on September 3, 1825 in Upson Co., Georgia. I have identified William as the brother of John Turner Alford by some very strong circumstantial evidence. In the 1870 Walton Co., Florida census he was living next door to John Turner, and William named a son after John Turner (as well as after Julius Charles and Henry Miles, two other brothers). In February 17, 1848 William Henry married Eliza Louviza Webb of Elbert Co., Georgia (11/4/1829-11/11/1857) in Muscogee Co., Ga., probably in the city of Columbus. Jefferey Oats performed the service. Eliza was the daughter of Fortunatus and Sara Webb, also of Harris Co., Georgia. Fortunatus Webb was the coroner of Harris Co., Georgia in 1835. Eliza had a first cousin, Phillip Elkane (Elkanna) Webb, who was living with William Henry's nephew, William Floyd Alford in 1860. Like William, his Father-in-Law was a Baptist minister. Muscogee Co. bordered Harris Co., where William grew up.

In 1849 he left the Harris/Muscogee Co., Ga. area and moved to Coosa Co., Alabama (north of Montgomery, AL), where in the 1850 federal census, he was listed as an overseer on a plantation. This move was probably in concert with the move of his father-in-law, Fortunatus Webb, who settled nearby. William also apparently followed Mr. Webb into the ministry. In about 1856 William moved south to Pike Co., Alabama (Mount Ida area), probably to take over a ministry there. On November 11, 1857, William's wife, Eliza died in Pike County. William and Eliza had five children together. On November 16, 1859 William married his second wife, Narcissus Nancy Pudgett (b. 1839 in Muscogee Co., Ga.) in Butler Co., Alabama. William and his family were listed on the 1860 Pike Co. census. On August 25, 1861 William's 2nd wife, Narcissus, died during childbirth in Butler Co., Alabama. She possibly was in the home of her parents in Butler Co. during this time. After losing his 2nd wife, William married his 3rd wife, Samantha M. Owens (4/1839-1/28/1921) on February 17, 1863 in Pike Co., Alabama. Shortly after marriage, on September 22, 1863, William joined the Confederate Navy and served until the end of the war in 1865.

Upon returning from the war, in around 1866, William moved to Butler Co., Alabama. His stay there was short-lived as in September 1867 he moved to Walton Co., Florida (according to daughter's Civil War pension application), where he was listed on the federal census as living in the Gaskin/Darlington area. His occupation was a teacher and minister. Here he finally caught up with his brother, John Turner Alford. In 1870 William Henry was living next door to John Turner in the Limestone area, near Darlington. William Henry was the founder and first minister of Limestone Baptist Church near Darlington, Florida. In about 1871, shortly after the death of his brother, John Turner Alford, William Henry moved to the Sandy Creek area of Holmes Co., Florida, not far from Lake Cassidy. The move was probably an effort to reside centrally in the middle of all the churches he preached at. In 1878 he was the Pastor of Sandy Creek and New Hope Baptist Churches in Holmes County. In 1879 he took on the additional pastorate of Limestone Baptist Church near Darlington in Walton County. In 1880, he shows on the census in the Sandy Creek area, six houses away from his daughter, Emma, and her husband, Abner Vaughn. Also not far away, were his daughter Alice and her husband, Daniel Smith. In 1880 he was Pastor of Sandy Creek, New Hope, Limestone, and Mt. Zion Baptist Churches in Holmes and Walton Counties. William's brother-in-law (by his first wife), Thomas J. Webb, was the church clerk at New Hope in 1880. Another brother-in-law, William H. Webb, was also active in the area churches as a clerk and messenger. The last mention I have found of William Henry in the

Limestone Church records, as minister is August 27, 1881. He was still the pastor of Sandy Creek and New Hope Baptist Churches in 1881. His son-in-law, Daniel Smith, husband of daughter, Alice Alford Smith, was his clerk at New Hope Church in 1881.

Around 1882 William, Samantha, and family went to Texas. Family legend has it that he was accompanied by two daughters of his brother, John Turner Alford. In 1886, according to his wife's widow's pension, the family moved to Shelby Co., Texas, near the town of Spivey (no longer exists), 7 miles north of Center. William Henry died in Shelby Co. on November 21, 1898 (10/23/1897 on tombstone), according to his wife's pension application. His burial was at North Jericho Cemetery in Shelby Co., about 7 miles north of Center, Texas on Jericho Creek (at the end of CR 3671). On June 12, 1900, while still a resident of Shelby Co., Samantha, his wife, filed for a widow's Confederate pension, which was granted on July 12, 1900. In 1900 the recently widowed Samantha was listed living as a boarder with Martha Braly in Shelby Co., Texas. Apparently, one of Samantha's sons married one of Martha's daughters, as there was a Willie Alford listed as Martha's grandson. The census also showed that Samantha had 7 children, with 6 living in 1900. Willie Alford (born 10/1889 in Texas) must have been the son of John Turner Alford, son of William Henry and Samantha Alford, who we lost track of after leaving Florida. In 1910 Samantha was living with her son, Samuel B. Alford in Newton Co., Texas. Samantha M. Alford died on January 28, 1921 of heart disease in Port Neches, Texas (Jefferson County), at the home of her son, Henry Miles Alford, with whom she had moved in with in the summer of 1920. According to her Mortuary Warrant, she was taken by train to Shelby Co. and buried at North Jericho Cemetery in Shelby Co., near Spivey. William Henry Alford had the following children by his 1st wife, Eliza:

Second Generation

(43) William Lafayette Alford was born on February 22, 1849 in Coosa Co., Alabama. He grew up in Coosa Co. and later in Pike Co., Alabama. In 1867 William moved to Walton Co., Florida with his parents (William Henry and stepmother, Samantha Owens Alford), living next door to his Uncle John Turner Alford. In 1871 he married Ursula Moore (1/26/1842-1928), daughter of Lovell (1795-1878) and Elizabeth Bennett Moore, (b. Randolph Co., Ga.) in Walton Co., Florida and soon moved to the Lake Cassidy area of Holmes Co., not far from Ponce de Leon. His homestead was about one mile west of Sandy Creek Baptist Church, on the dirt road. William Lafayette appeared on the 1885 Florida State census for Holmes Co., living next door to his sister Alice Booney Alford Smith and brother-in-law, Daniel Smith.

A farmer, by occupation, he was still there in 1900 according to the federal census. William Lafayette, a literate man, died on December 10, 1918 (death certificate) in Holmes Co. at home near Bridge Creek. Leslie Davis, a cousin of this author, a childhood neighbor, relates an interesting story about old Mr. Alford. Around 1917, a year before his death, William Lafayette was traveling in his buggy on the Limestone to Red Bay road and got stuck in the mud. Leslie's mother sent him (age 7 at the time) to help him out.

William Lafayette's wife Ursula, known as Sula died in Holmes Co. in 1928, at 86 years of age, and is buried at

Sandy Creek Cemetery in Holmes County. Sula had moved to Walton Co. in 1850 with her parents and siblings. Her brothers, Lovell, Ezra, William, George Washington, and John S. also settled in Walton County. She was listed on the 1920 Holmes Co. census as a widow, living with her son, Charles Lovell Ezra Alford, in the Bridge Creek Precinct, near Ponce de Leon. According to death certificates, both were supposedly buried at Sandy Creek Baptist Church Cemetery, but the graves cannot be found. William Lafayette and Sula Alford had the following children:

(44) Mary Mattie Indiana Francis Alford, daughter of William Henry Alford, was born on May 22, 1850 in Coosa Co., Alabama. She spent most of her teenage years in Coosa and Pike Counties in Alabama, but in 1867, she moved to Walton Co., Florida with her parents. In 1870 she was shown living at home with her parents in Darlington, Florida. About 1872 she married Ruben Davis (1852-unknown / b. Alabama) found living with his mother, Clara Davis in 1860 Holmes Co. census), probably in Holmes County. They moved across the state line to Geneva Co., Alabama shortly after marriage in 1872. Around 1878, Ruben and Mattie moved to the East Bay/Holley area of south Santa Rosa Co., Florida, where they appeared on the 1880 Federal Census. This was in the same area where Mary Indiana's Uncle Henry Miles Alford was living. By 1885 they had moved back to Holmes Co., possibly to live in Ruben's mother's old house. She had died about this time. The couple is shown living in the New Hope Community in Holmes Co. (state census) in 1885. At that time, Mary's brother, Henry Miles Alford, was living with them. Although I have no proof, Mary apparently died 1897 during childbirth. Mary's minor children, born from 1885-1897, were living in Shelby Co., Texas in 1900 with their Uncle, Henry Miles Alford. The last child, Margaret L. Davis, was born in Florida in March of 1897. It is not known when her husband died. Nothing else is known about her.

Mary Indiana Alford Davis had the following known children: Hattie Davis (1873-? / b. Geneva Co., AL), Burnsting Davis (1875-? / b. Geneva Co., AL), Dal Davis (1877-? / b. Geneva Co., AL), Unnamed daughter (1880-?), Martha Davis (5/1885-unknown / b. Holmes Co., Fla.), Elizabeth Davis (3-1887-unknown / b. Holmes Co., Fla.), Jesse Leon Davis (2/1891-unknown / b. Holmes Co., Fla.), Thomas James Davis (7/1892-unknown / b. Holmes Co., Fla.), William F. Davis (11/1893-unknown / b. Holmes Co., Fla.), and Margaret L. Davis (3/1897-unknown / b. Holmes Co., Fla.).

(45) Emma Eliza Alford, daughter of William Henry Alford, was born in Coosa Co., Alabama (Wetumpka) on April 12, 1852. In 1867 she moved with her parents to Walton Co., Florida. On January 27, 1870 she married Abner Michael Vaughan (9/16/1841-5/9/1905) in Holmes Co., Florida. The couple shortly moved to the Lake Cassidy (Sandy Creek) area of Holmes Co., Florida, apparently due to the move there of Emma's parents. From 1878-1880, Emma's brother-in-law, John Angus Vaughan, served as clerk of New Hope Baptist Church, under her father, William Henry Alford. In 1880, the Federal Census shows them living six houses away from Emma's parents in the Sandy Creek community. By 1900 (Federal Census) the couple had moved to the Matthew's Mill community (near New Hope) of Holmes Co. near the Alabama line off Highway 2. Emma, a very literate lady, lived in Holmes Co. (in the New Hope community) the rest of her life, and died there on October 17, 1915. She is buried at Mt. Ida Methodist Church near New Hope (Holmes County). Abner, who preceded her in death in 1905 is also buried there. On December 12, 1905 Emma was approved for a CSA Widow's pension for her deceased husband.

Emma and Abner had the following children: Giles Bowers Vaughn (10/27/1870-2/6/1916 / b. Holmes Co., FL / m. Vitrell C. Matthews), Mary Vaughan (9/27/1872-7/31/1910 / b. Walton Co. / m. J.P. Cowan), Fenner Vaughan (11/3/1877-10/3/1912 / d. in Cottondale, FL (Washington County), Millard Alford Vaughan (4/14/1883-2/14/1913 / m. Nellie ? B 3/18/1888-10/26/1972), Oscar Vaughan (1/13/1881-12/27/1961 / m. Mary Etna Howell), Alma Camilla Vaughan (1/1/1890-7/1968 / m. John Thomas Edwards 1905 / buried Kabrich Cemetery in Arcadia, Fla.), Margaret Maggie Vaughan (12/1875-aft 1900), and Henry Vaughn. Tommie Lee Petty McNair, a descendant of Emma, through her son Giles Bowers Vaughan, is currently helping research this family.

(46) Alice Booney Alford, daughter of William Henry Alford, was born on March 10, 1854 in Coosa Co., Alabama. She spent most of her childhood years in Pike Co., Alabama, however, in 1867 she moved to Walton Co., Florida with her parents. In 1870 she is shown living at home with her parents. In about 1872, Alice, a literate woman, married Daniel Smith (1/16/1852-1/22/1935) in Holmes County. They set up their homestead in the Sandy Creek area of Holmes Co. immediately after marriage. In 1880 (federal census) the couple still lived in the Sandy Creek area of Holmes Co., not far from her sister, Emma, and her father William H. Alford. Her cousin Jane Alford

Tadlock and her husband Benjamin lived two houses away. In 1885 (state census), Alice and Daniel Smith were living next door to William Lafayette Alford, Alice's brother, who had taken over his father's land. William Henry Alford had gone to Texas around 1882. From 1881 to 1885 Alice's husband, Daniel Smith, was the clerk at New Hope Baptist Church in Holmes Co., serving for a while under his father-in-law, William Henry Alford, the pastor. He later served as pastor of the church. Sometime in the early 1890s (after their last child was born), the family moved to Bristol, Florida (Liberty County), just southeast of Holmes County. In 1900 (Federal Census) they were shown living in Bristol. They lived there the rest of their lives. Daniel died in 1935 and Booney died a year later, on May 26, 1936. They are buried at Lake Mystic Cemetery just south of Bristol.

Booney and Daniel Smith had the following children: Mary L. Smith (1873-unknown / b. Holmes County), Daniel Matthew Smith (9/6/1875-6/27/1898 / b. Holmes Co. / d. Liberty County), Mahala F. Smith (4/15/1878-12/4/1959 / b. Holmes Co. d. Liberty Co. / m. 11/17/1899 Henry Mitch Strickland), Alice Serena Smith (2/9/1880-10/18/1927 / b. Holmes Co. / m. 12/30/1901 Augustus Benton / died Liberty County), Nettie E. Smith (3/6/1885-4/24/1963 / m. W.A. Preacher / b. Holmes Co. d. Liberty County), Ellen Genora Smith (2/1888-1943 / b. Holmes Co. / m. 9/22/1913 Jacob Oscar Colvin / d. Liberty County), and Gypsy L. Smith (5/8/1889-12/1979 / b. Holmes Co. d. Polk Co., FL / m. ? Crowder).

(47) Thomas James Tom Alford, son of William Henry Alford, was born on November 11, 1857 in Pike Co., Alabama. His mother, Eliza, died after giving birth to him. He was named after his maternal uncle, Thomas James Webb. Around 1867 he moved with his parents to Walton Co., Florida. In 1871 he moved with his family from Walton Co. to Holmes Co., Florida in the Lake Cassidy area. Thomas James married Catherine W. Neal (9/9/1844-2/9/1909) in 1876 in Holmes County. Catherine was the daughter of David and Margaret Neal of Holmes County. David Neal was the Church Clerk at Sandy Creek Baptist Church under Thomas's father, Rev. William Henry Alford, from 1878-1880. The family shows on the 1880 Federal Census for Holmes County. Around 1882 James headed for East Texas, with his parents, apparently leaving his wife and children in Florida. Catherine, James's wife, was shown living near Westville, Florida (Holmes County) in 1900 as head-of-household, with her two children. She died February 9, 1909 in Holmes Co., and is buried at the Westville City Cemetery.

Thomas James moved back from Texas, to the New Hope area of Holmes Co., prior to 1905. It is not known whether or not he rejoined his wife, Catherine. In 1919 James married Lena Simmons (8/1879-unknown) of Westville and settled in Westville after marriage. Lena was born, Eva Lena Stanton, daughter of Chalmers Stanton of Westville. Her first husband was Joseph Simmons, who died around 1912. Thomas James Tom Alford was shown on the federal census, as living in Holmes Co., Florida with Lena in 1920. He also had four Simmons stepchildren (Charles Charlie Simmons b. 1904, Hollie Simmons b. 1906, Ira Simmons b. 1908, and Mabel Simmons b. 1911). Thomas James Alford died on August 20, 1931 (death certificate) in Holmes County. His step-grandson, Thomas Simmons of New Hope, Florida says he remembers Tom Alford riding him around in a wagon in the early 1930s. According to his death certificate, Thomas was involved in the grocery business. He was buried at the Mt. Ida Cemetery (grave unmarked) near New Hope, Florida in Holmes County. Lena Alford is buried at Westville Cemetery with her first husband. Thomas James had no children with Lena. Thomas James and Catherine Alford had the following children:

(48) Susan Antoinette Alford, daughter of William Henry and Samantha, was born on December 15, 1863 in Pike Co., Alabama. In 1867 she moved to Walton Co., Florida with her parents. In 1870 she is shown living with her parents, near Darlington, Florida. Nothing else is known of her.

(49) John Turner Alford, son of William Henry Alford, named after his Uncle John Turner Alford, was born on April 16, 1867 in Butler Co., Alabama. Soon after birth his parents moved to Walton Co., Florida, and later on to Holmes Co. He moved to Shelby Co., Texas, as a teenager, around 1882 with his parents. In 1888 he married Lenora Braly (1866-1900) in Shelby County. It appears that John died about 1890 in Shelby Co., Texas, as Willie was living with his maternal grandmother, Martha Braly, in 1900. There were no other children born after 1889. His mother, Lenora, and his paternal grandmother, Samantha Owens Alford, were also living in the same household. John and Lenora had one child:

(50) Henry Miles Alford, son of William Henry Alford, named after his Uncle Henry Miles Alford, was born on

May 5, 1868 in Walton Co., Florida. He moved with his parents to Holmes Co. around 1875, just next door to Walton County. In 1885 (state census) Henry, a railroad worker, had moved from home, and was living with his sister, Mary Indiana, and her husband, Ruben Davis, in the New Hope community of northern Holmes County. Around 1886 he moved to Shelby Co., Texas, apparently in an attempt to join up with his parents, William Henry and Samantha M. Alford, who had also settled there in 1886. About 1890, in Shelby Co., Texas, he married Leila Estelle Sandlin (6/9/1872-11/5/1958), daughter of Reverend Jesse B. Sandlin, a fellow minister of Henry's father, William Henry Alford. Henry Miles, a carpenter by occupation, was living still in Shelby Co., Texas, in 1900, according to the Federal Census. At this time he was raising the children of his apparently deceased sister, Mary Indiana Alford Davis. By 1920, Henry had moved to Port Neches, Texas (Jefferson County). He was taking care of his ailing mother, Samantha Alford, who died at his home in Port Neches in 1921. Henry received the mortuary account to bury his mother and assumed the responsibility to pay any indebtedness of his mother. On January 3, 1924, Henry Miles Alford died in Jefferson Co. of heart disease. His attending doctor was Dr. Welch, who had also been his mother's doctor. He was buried at Ramah Cemetery 3 miles east of Tenaha on US Highway 84 in Shelby Co., Texas.

Leila Alford survived her husband and died in 1958, and is buried next to him at Ramah Cemetery. Henry and Leila had the following children:

Charley moved to Shelby Co., Texas with his parents in about 1882. He married Lillie Brown (1876-?) in 1895 in Shelby Co., Texas. In 1900 the family was listed in Shelby Co. (52) Samantha Alford, daughter of William Henry Alford, named after her mother, was born in 1874 in Walton Co., Florida. Nothing further is known of her.

(53) Sarah Alford, daughter of William Henry Alford, was born in Walton Co. or Holmes Co., Florida in 1877. Nothing further is known of her.

(53a) Samuel B. Alford, son of William Henry Alford, was born on August 11, 1880 in Holmes Co., Florida. He went to Shelby Co., Texas as a child with his parents in 1882. He grew up in Shelby Co., Texas, and married Ethel Murray (1885-aft 1952 / b. Oklahoma) there in about 1902. In 1900, Samuel was living as a single man in Newton Co., Texas, just north of Beaumont (Jefferson County). He was boarding with a man named W. George Smith and worked in a livery stable. In 1910 (Federal Census) he was still a resident of Newton Co., Texas, living with his wife, Ethyl, children and mother, Samantha M. Owens Alford. Her husband, William Henry Alford, had died on October 23, 1897, probably in Newton Co., Texas. It appears, with children being born both in Louisiana and Texas, that Samuel moved around a lot in the early 1900s along the border area of the two states. He probably followed jobs in the oil industry of the area. Ethyl, his wife, apparently died around 1905 after giving birth to her son, Amos Alford. Samuel was living in Newton Co. in 1920 (census) with his second wife, Mittie Sims (1895-bef 1952) and apparently lived in there until 1936, when he moved his family south to Beaumont, Texas (Jefferson County). He lived at 119 East Lucas Drive in Beaumont for most of the rest of his life. His death occurred while residing at Schlesinger's Nursing Home in Beaumont, where he suffered from hypertension. For most of his working years he was an engineer with the Sabine Tram Company in Beaumont, but turned to gardening during retirement. On June 8, 1952 he died of a cerebral hemorrhage in Beaumont. He is buried in Forrest Lawn Cemetery in Beaumont. His wife, Mittie Sims Alford, had died prior to his death. Samuel and Ethel Alford had the following children:

Now, we will discuss the grandchildren of William Henry Alford, son of Job Alford. We will start with the children of William Lafayette Alford. **(139) Savannah Alford**, daughter of William Lafayette Alford, was born in 1872 in Holmes Co., Florida. According to the old Alfords, she married around 1891-92 and died giving birth to her first child around 1892. Information on the 1900 census concerning her mother (number of children living), verifies her death before 1900. Nothing else is known of her.

(140) William Chorner Alford, oldest son of William Lafayette Alford, was born on May 17, 1874 in Holmes Co., Florida near Lake Cassidy. He appears to have been named after his Uncle Chorner Alexander Alford, who died as an infant in 1861. In 1899 William Chorner married Hattie Scott (1/7/1886-4/2/1962) in Holmes County. In 1900 he is listed on the Holmes Co., Florida census in the Sandy Creek precinct. William made a living as a day laborer in the turpentine industry. Living with him at the time, was his brother Lovell Ezra Alford and his wife, Rebecca Nowling Alford. A literate man, William Chorner Alford, a deeply religious man, died as a relatively young man of a heart attack, on June 7, 1911 in Holmes County. He is buried in Sandy Creek Baptist Church cemetery in Holmes County. This is an old marker near the front gate. Hattie Scott Alford later married Jesse Hardy. She died of cancer about 1962 and is buried with her second husband at Sandy Creek Cemetery. William Chorner and Hattie Alford had two children:

(141) Charles Lovel Ezra Alford, son of William Lafayette Alford, was born on February 23, 1877 in Holmes Co., Florida. Named after his grandfather, Lovel Moore and Uncle Ezra Moore, he grew up in Holmes Co., near Lake Cassidy, and married Rebecca Nowling (1/10/1885-1/20/1966 / b. Holmes County) in Walton Co., Florida in 1900. The 1885 Florida State Census shows him (listed as C.L.E. Alford) living with his parents in Holmes Co., Florida. In 1900 Love Alford and his wife were living with his older brother, William Chorner Alford. In 1917 he registered for the draft in Holmes County. In 1920 Love was still living in Holmes County. In about 1930 Love and Rebecca moved to Polk Co., Florida to farm. He stayed there until about 1932, when he moved back to the area and settled at Eucheana in Walton County. He stayed at Eucheana until about 1936, when he moved back to Holmes Co. near Ponce de Leon. Rebecca died on January 20, 1966 in De Funiak Springs, Florida at Walton Co. Hospital. After the death of his wife Love moved to Panama City, Florida, where he stayed with relatives. After a short stay there he moved back home to stay with his son, William Purlis Alford. By late 1967 he moved into the nursing home in Bonifay, Florida. Love died on July 15, 1968 in Bonifay (Holmes County). Love Alford, an avid fisherman, was a very religious man and was a member of Sandy Creek Baptist Church. Several people had said he was one of the best men they ever knew. Love and Rebecca are both buried at Sandy Creek Baptist Church Cemetery in Holmes County. They had the following children:

(142) Elizabeth Alice Alford, daughter of William Lafayette Alford, was born in September 1882 in Holmes Co., Florida. She grew up in the Sandy Creek area of Holmes Co., just northwest of Ponce de Leon. In 1900 she was living with her mother, Catherine Alford, in Westville. She married around 1918 and died giving birth to her first child, as her older sister, Savannah, had. Nothing else is known of her.

Another son of William Henry Alford was Thomas James Alford, born in 1857 in Pike Co., Alabama. His oldest child was **(143) Margaret Louise Alford**, named after her maternal grandmother, Margaret Louise Neal. She was born in July 1877 in Holmes Co., Florida. In 1900 she was still living with her mother in Westville, Florida. Around

1903, she married Herbert Thorton (?-?) in Holmes County. Nothing else is known of the family, except the fact that she died prior to her brother, who died in 1958.

(144) William David Alford, son of Thomas James Alford, named after both of his grandfathers, was born on April 17, 1879 (death certificate) in Holmes Co., Florida. In 1900 he was listed on the Holmes Co. federal census, as living with his mother. His father had gone to Texas for a while. At this time he made his living as a day laborer in the turpentine industry. In 1917 William registered for the draft in Holmes County. In 1920, William was listed on the federal census as a boarder of Julian Coeey in Holmes County. His various occupations included being a telegraph operator, electrical engineer, and railroad agent. In 1922 William moved to Perry, Florida (Taylor County) from Holmes County. There he became a member of the New Home Baptist Church. On April 5, 1958 (death certificate) William died in Perry at Doctors Memorial Hospital, following a week's illness resulting from being hit by a car while crossing Hwy 19 in Perry. Both legs were badly broken and he was badly bruised and shaken elsewhere. He is buried at Woodlawn Cemetery in Perry. His obituary stated that his only living relatives were cousins with the Coeey surname and Mrs. Sarah Shiver. William David never married.

(145h) Murray Alford, son of Samuel B. Alford, was born on January 14, 1903 in Newton Co., Texas. He grew up there and married Eleanor Alice Kemp (8/15/1909-unknown / b. Elkhart, Indiana) (date unknown). By 1930 Murray had moved to St. Louis, Missouri. Sometime around 1933 Murray moved to Syracuse, New York (Onandoga County) and was living there on Liverpool Road in 1933. That same year he became a hotel manager there and worked at that occupation until his death. Murray was killed in an automobile accident on April 8, 1935 in Onandoga Co., New York. (145i) Amos Alford, son of Samuel B. Alford, was born on December 19, 1904 (SSDI) in Louisiana. In 1920 he was living with his parents in Newton Co., Texas. He married Thelma ? (5/6/1907-12/1985) (place and date unknown). In 1952, at the time of his father's death, Amos was living in Chicago, Illinois, where he lived until his death. He died in August 1978 in Cook Co., Illinois. His last residence was Palos Heights, a suburb of Chicago. His wife survived him and died in 1985 in Cook County. Nothing further is known of him.

(145j) Edgar Macon Alford, son of Samuel B. Alford, was born on May 11, 1919 in Newton Co., Texas. In 1952 Edgar was living in Los Angeles, California, where he died on November 4, 1996. Nothing else is known of him.

(145k) James Alford, son of Samuel B. Alford and his second wife, Mittie, was born around 1922 in Newton Co., Texas. He grew up in Newton Co. and as a teenager, in Beaumont, Texas (Jefferson County). In 1952, at the time of his father's death, he was living in Galveston, Texas. Nothing else is known of him.

(145l) Sybil Alford, daughter of Samuel B. and Mittie Alford, was born in 1924 in Newton Co., Texas. She grew up there and, later, as a teenager, in Beaumont, Texas. She married a Mr. Starnes (?-?) in Beaumont, and was living there in 1952.

(363) Annie L. Alford, daughter of William Chorner Alford, was born on July 3, 1904 in Holmes Co., Florida. She grew up in the Bridge Creek area of Holmes County. After the death of her father, William Chorner Alford, she was raised by her mother and stepfather, Jesse J. Hardy. In 1925, Annie married Pleasant Hart. By 1945 (Florida State census), Annie and Plez Hart had moved to De Funiak Springs, Florida (Walton County). Annie died in March 1983 in De Funiak Springs, and her husband died one month before her. They had the following children: Wilburn C. Hart (1926-unknown), Helen L. Hart (1928-unknown), Muriel Hart (1930-unknown), Donald Hart (1933-unknown), Arnold Hart (1936-unknown), Annie Jo Hart (1943-unknown), and Willie Jean Hart (1945-unknown).

(363a) Millard Lewis Alford, son of William Chorner Alford, was born on October 15, 1907 in Holmes Co., Florida. After the death of his father, he was raised by his mother and stepfather, Jesse J. Hardy. He grew up in Holmes Co. and married Thelma Etheridge (3/20/1914-6/30/1951) about 1929 in Holmes County. In 1935 (Florida State Census), Millard lived in the Bridge Creek area of Holmes Co., where he owned his home and ran a small farm. In the late 1930s or early 1940s, he moved to De Funiak Springs in Walton County. For most of his years in De Funiak Springs, Millard worked as an automobile mechanic for Rivard Chevrolet Company. His wife Thelma

died in 1951 and he lived as a widower until his death on January 7, 1969 in De Funiak Springs, Florida. He is buried at Sandy Creek Cemetery 6 miles northwest of Ponce de Leon in Holmes County. His children were:

In 1933, his family moved to Syracuse, New York, where his father was killed in an automobile wreck in 1935. After the death of his father, his widowed mother apparently moved back to Indiana, where her parents lived. He married Jaqueline Speckman (8/24/1929-living / b. Dearborn Co., Indiana) (date and location unknown). Nothing further is known of them, except that he lives in Indiana.

In most cases I list the first marriage, however, in the body of the work, I cover all marriages. Also, when I list a child as probable , it is with extensive circumstantial evidence, that I would be happy to provide upon request. Remember, all of this is a work in progress. If there is any one out there, with more or different information on any of these individuals, please contact me via e-mail.

John, son of Yvonne Alford and John Thomas Rogers, has been active in our organized Alford effort for over ten years and is our leading authority on most of the Alford's descending from Job Alford. For those not familiar with him, this is Job Alford, son of Julius and Lucy Newton Alford of Franklin Co., NC. Job, along with some of his brothers moved to Georgia in the very early 19th century.

The numbering system used in this small part of John's work is an extension of those used in a much larger file he has on the family. We hope to see more similar segments from John in the future.

This is the first segment I will be contributing to AAFA ACTION in an effort to inform Alford researchers and members about the family and descendants of Job Alford, who migrated to places such as Alabama, Florida, Arkansas, Texas, and Oklahoma. I have found this to be quite an undertaking, as there are thousands of descendants. I have had a tremendous amount of help in this effort and I have worked closely with other descendants, such as Laura Alford White, William Edward Eddie Alford, and Wendell Meggs. I will begin this series of installments with a family background on Job Alford, cover his life and migrations, and list his known children. In future segments, I will cover each child, and who knows maybe grandchildren, if time suffices. (1) **James Alford**, probable son of John Alford, Sr., was born in 1687 in New Kent Co., VA (St. Peter's Parish). In about 1707 he married an unknown spouse in New Kent County. On September 6, 1710, St. Peter's Parish, for keeping a foster child, awarded him 420 pounds. On September 29, 1718, James was listed in the parish register as a highway surveyor. He died about 1730 in New Kent County. James had the following children:

(6) Julius Alford, son of James Alford, Sr., was born in September 1717 in New Kent Co., VA. He grew up there, but as a young adult moved to Bertie Co., NC around 1739, with his brothers, Goodrich, Lodowick, and Warren. In 1741 Julius Alford, a North Carolina militiaman in 1754, was cut into newly formed Edgecomb County, then in 1746 cut into Granville County, then in 1764 cut into Bute County, and finally into newly formed Franklin County in 1779. In 1745 Julius married Lucy (maiden name unknown) in then Edgecomb Co., NC. Julius and his brothers had moved to two areas in what was then Bertie County in northern North Carolina: Julius in the Crooked Creek-Tar River area of current Franklin County and in the case of Lodowick, Warren, and families, the Little Creek area in current Wake County. Both of these areas were homes to substantial Alford settlements between 1740 and 1820. In July of 1768 Julius filed his will in St. John s Parrish of then Bute County (now Franklin). He died in November of 1771 at the age of 54. Lucy, his wife, died between 1790 and 1800. Julius and Lucy Alford had the following children:

(13) Job Alford, son of Julius Alford, was born in 1763 in then Granville Co., NC. He was the forefather of the Alford's who came to Geneva Co., AL; Walton Co., FL; and Holmes Co., FL in the mid-1800s. Today, Job has descendants in virtually every county of the Florida panhandle.

Job Alford s birthplace was on his father s plantation, where Crooked Creek flows into the Tar River, just about 4 miles southeast of the current town of Bunn, North Carolina. This was just inside current Franklin County from Nash County. Julius was the son of James Alford (1687-1730) of New Kent Co., VA. James was the probable son of John Alford, Sr. (1645-1710) of New Kent Co., VA. In 1790 the Federal Census for North Carolina lists Job as a single man living in the Louisburg District (town of Bunn) of Franklin County, near the Tar River. He was listed also as the owner of six slaves. Job s older brother, John Alford, lived nearby. Also living nearby was his widowed mother, Lucy Alford (his father, Julius, had died in 1771). Brothers Isaac and Goodrich are not shown as heads of household in 1790; I would assume they must have been living with a brother, or were simply missed.

By around 1794 Job Alford married. The name of his wife is unknown, however much circumstantial evidence points to his wife being a Sarah Turner (abt 1765-abt 1843). In the same area of Wake County where the Job lived in the early 1790s was a family of Turners. There was a Simon Turner and his wife Nancy Ann Smith Turner living nearby. Simon and Ann Turner had several children, including a John Turner, Mary Turner and others. It is also possible there could have been a Sarah Turner. In the area there was a John Turner (1770-1787), who died as a teenager. Simon Turner also had an uncle named John Turner. The name, John Turner, ran in this family back for several generations. It is my proposal that Job and his wife named John Turner Alford, their second son, after his wife s young brother, John Turner, who died as a teenager. Three of Job s children, John Turner, Fada, and Henry Miles, named their first female child Sarah Ann. One naming convention of the day was to name the first female child after the paternal grandmother. This leads me to the theory that, Job s wife may have been named Sarah Turner.

There were no males shown living with Job s mother, Lucy, in 1790. By 1800 Job had moved west to edge of Wake Co., NC, settling near his 1st Cousin James Lodowick Alford, where he showed as a married head-of-household (2 sons under 10, 2 daughters under 10) with one slave. The two sons under 10 were apparently Clinton and John Turner Alford, and the two daughters were apparently Phada, John Turner s twin sister, and Matilda. On July 16, 1802, Job was one of several purchasers in the estate sale of the deceased David Bagwell, of Wake County. Seven years later, on March 16, 1809, he once again participated as a buyer in the estate sale of Miles Previtt of Wake County. Wake County paid Job on April 5, 1811 to travel to Virginia to attend a court proceeding. The last documented record of Job living in Wake County was on August 20, 1814, when he was the bondsman at the marriage of his oldest daughter, Matilda Alford and William Owens.

There were several Alford's living near him in this area of Wake County in 1800, including, Hudson, Cade, and James Lodowick Alford. Several other Alford's, including Goodrich, Isaac, John, and Kinchen, lived in and around the old Alford homestead in Franklin County in the Crooked Creek-Tar River area, where their father, Julius lived

and was presumably buried. The town of Louisburg exists to this day. Job left North Carolina after the War of 1812 (in 1815, as he was still on the Wake County tax list in 1814 but not 1815) and headed towards Jones Co., GA, to join his older brother Goodrich, who had drawn land there in 1811. Another older brother, Jacob, had moved to Montgomery Co., GA in the 1790s, but soon moved on to Louisiana, where today he has many descendants. Brother Isaac stayed in Franklin County, where he lived out his life. Job's oldest brother, John stayed in Franklin County until around 1826, when he moved to Greene Co., AL to live near his sons, Abraham Alford and Jacob Alford, both first cousins of Job. Job may have stopped and lived in South Carolina for a couple years from about 1815-1816, as his probable son, Henry Miles Alford, was listed on later censuses as being born in South Carolina in 1815. In 1977, a descendant of Job, by way of his son, William H. Alford, wrote a letter to a friend, stating that the Alford's came through South Carolina and the town of Hartwell, Georgia on their way to Jones County.

By 1817 Job had arrived in Jones Co., GA, as he, and his son, Clinton, were on the tax list there in that year. His son-in-law and daughter, William and Matilda Owens, also moved to Jones County that same year. In 1820 he was listed on the Jones County census, living in the Clinton Township. That year Job was granted land in Early County in the 1820 land lottery, but apparently never moved there. Four of Job's children, John Turner, Clinton, and Julius Charles, as well as Matilda Alford Owens, became members of the New Hope Baptist Church on Caney Creek in Jones County. Job's wife, Sarah Alford was also a member. The church was still in operation (3/10/2000) and is located three miles northeast of Dames Ferry. Also a member was Elizabeth Stilwell, the future Mrs. William H. Alford, another son of Job Alford. Her father, Shadrick Stilwell was another member. Clinton, Georgia still exists today and is on Highway 129, 12 miles north of Macon. Job's older brother, Goodrich was also in Jones County in 1820. It appears Goodrich died around 1825-27 in Jones County. He had several children, to include probable sons, Goodrich, Jr. and Jephtha. Job won land in the Monroe County land lottery in 1821, causing another westward move probably around 1822 (son, Clinton, was dismissed from New Hope Primitive Baptist church in Jones County by letter in 1823 meaning they had probably moved already to Upson) to the part of that county to become Upson County in 1824. Here, sons John Turner, William H. and daughter Phada were married in the mid-1820s. Job was in Upson County until at least 1827. Around 1828-1829 he moved to Talbot County, immediately west of Upson County.

In 1830 Job, as well as several of his children were listed on the federal census for Talbot Co., GA, but by 1833 (letter dated 10/1/1833 at Hamilton Post Office addressed to his son William H.) he was in Harris Co., GA. On October 18, 1850, the federal census shows him in the Osborn Mill District of Harris County (town of Mulberry Grove) where he lived until his death about 1851. Also in 1850, Job's granddaughter, Sarah Ann Moore Hadley (daughter of Phada Alford Moore), lived two houses from him, with her husband. His daughter, Phada, and her husband, Thomas Moore, lived eight houses away. One unsolved mystery is the fact that we cannot find Job on the 1840 census. In later years he lived with his daughter, Elizabeth, and probable granddaughter, Rebecca Ann. Although it is not proven, Job was probably buried at the Blue Springs Cemetery, where his daughter, Phada, and her family were buried. This was the general area cemetery. Job and his wife Sarah Turner Alford (theory) had the following known or probable children:

While the original genealogy was compiled by several others in the 1800s and 1900s AAFA is making significant change and addition to that effort so it is being considered a new compilation. Not particularly significant, but important to those using the genealogy as a basis for further research locations are being expanded to include the county where possible.

The original work listed only town or township and state. A different register numbering system is being used. The original work carried female lines only one generation, i.e. it listed the children of the Alvord female but ended there. Where the information is available from a number of other sources all the known descendants of the females are being listed. It is expected that only part of the fourth generation will fit in the next issue.

We are doing all possible to maintain integrity and continuity in the register numbers from one issue to the next. However, if information is received on a descendant who must be entered in the file in a position earlier than that being published then register numbers will be revised accordingly.

Except where otherwise indicated all of this segment came from the 1908 Alvord book.

The first deed of property to Thomas Alvord recorded at Middletown, Conn., is dated Apr. 28, 1726, Robert Coe for 25 pounds deeds twelve acres of land in the southernmost tear or range of lots to Thomas Alvord, "now a resident of Middletown," bounded, E and N. by highway, S. by land of Robert Coe, W by land of Moses Parsons, The grantee was given two years in which to pay the price of the land or forfeit the same. Later grants were also on west side of the river. With his wife, Mary, he joined the first church in Middletown by letter from Northampton Mass. Mar. 16, 1729. Thomas Strong, Mrs. Alvord's father, had moved to Durham, Conn., previous to this time, which undoubtedly led Thomas Alvord to the neighboring locality.

While living in Northampton, Thomas Alvord was a garrison "soulder" in the Meadow Fight at Deerfield in Feb., 1703-4, being one of the eight men to go from Northampton to aid the inhabitants of Deerfield against the Indians. In 1723 he signed a petition at Northampton to sustain the commissioners in the matter of changing the course of Mill River. He owned the house, barn and hatter's shop which about 1730 went into possession of Dr. Ebr. Hunt. In 1724 he received 4 pounds for ringing the bell at Northampton.

Mar. 31, 1767 Thomas Alvord of Middletown conveyed to his son Thomas all his property, "having been supported by him for several years and bound to be for the residue of life." His death was due to "the infirmities of old age."

Thomas Alvord's first wife was drowned in company with her brother. The boat upset. They clung to it for a time, but no help reached them, and they were both drowned.

At a meeting of the Precinct (afterwards South Hadley) 10 August 1733, voted: that the day for the ordination of Grindell Rawson shall be the third day of October next with the concurrence of Mr. Grindell Rawson." "Voted that Ebenezer Moody, Nathan-II White, John Alverd, Dan-II Nash and John Smith be a comitte to send for ye assistance of such ministers and messengers of Churches as they shall think best for ye ordination." etc.

In 1741 trouble arose between Rev. Rawson and his church. John Alvord was one of a committee of fifteen appointed to force him to cease to occupy the pulpit. Rawson persisted and was dragged from the pulpit by the committee of young men employed by them for this purpose.

In an interview with Sylvester Judd, Gardner, Preston, b. 1748, said that he remembered John Alvord.

"His house was west of the road, north of Brewster's Brewster is said to have lived on the bank of the Conn. River below the ferry, some distance, a recent settler . He did not remember his son John. Job and Gad were clever men. Gideon lived by the ferry, Elijah lived in second house north of Rod Smith's. He was a trader, went to Greenfield, failed." Gideon Alvord, son of John, had the small pox in the Army in 1757. He came home with his stockings not cleaned. His mother washed them and took the disease, when the small pox first appeared, many of her children and grandchildren, and others who had been exposed, were inoculated and John Alvord's house became a pest house. Drs. Crouch and Kellogg of Hadley took care of the patients from October 28 , until December 28, 1757. John Alvord (prob. John, Jr.) is said to have died of this disease, and probably John Alvord himself." (Hist. of Hadley)

His grave stone is still (1908) standing at So. Hadley.

He believed that his wife's insanity was caused by Bernard's wife's witchery and his son Benjamin believed the same." (Judd Manuscript)

Benjamin Alvord, Sr., was named in the settlement of his father's estate as eldest son and was allotted a double share. He was a weaver and learned the trade at Hadley, Mass. His weaving accounts begin in 1713. He resided on Market street after 1743. His previous residence was at the end of the plain next to the Connecticut River near the river bridge and he tended ferry. He was chosen constable in 1743, 1744, 1747, and 1749. He was a great reader and had many books on divinity.

Benjamin Alvord served as drummer in Father Rale's Indian War, 1722-25, and was also in the "Seven Year's War," 1775. He was especially famous as an "express rider" and served as such in three wars. He was very active in the Indian troubles 1722-26, riding between Albany and Northampton, and Northampton and Boston. Joseph Hawley speaks of his coming from Albany as a "rapid transit" post rider and being ordered on to Boston. Hawley, in June, 1724, thought it "much boldness for one to travel alone" but Alvord was not afraid. He made the trip from Albany to Northampton in one day. The pay for the trip was 3£, sometimes 3£ 6s. His services were in great demand and he was employed as a messenger in town affairs in 1743.

"Mr. Benjamin Alvord died in his chair suddenly and alone Oct. 22, 1772." (Northampton Town Rec.)

Medad Edwards told Sylvester Judd that Nathanile and Noah Edwards were greedy of gain and buried their father-in-law alive to get his property. Mr. Judd did not believe this to be true.

Joseph Alvord resided in Northampton, Mass. on the estate he bought of Joseph Clesson, situated on the road to Hadley about one half mile from the bridge across the Conn. River. Abstract of a deed now in possession of a descendant:

"Joseph Clesson lately of Northampton, now of Deerfield, husbandman, in consideration of the sum of two hundred and sixty-five pounds paid by Joseph Alvord, March 26, 1730," conveyed, "a certain homelot in the town of Hampton wt a dwelling house and barn standing thereon which homelot is bound as follows, viz: upon the highway northerly and upon Ebenezer Wright's Jun. lot, or the heirs of Judah Wright, deceased, lot; southerly upon the highway eastwardly and on the land of Moses Layman and Gideon Layman, westwardly, which lot contains five acres and a half. or there about be it more or less.

Joseph Clesson."

On the above place Joseph Alvord lived and died; here all his children were born; here resided his son, Medad Alvord, also his grand-daughter, Eunice Alvord, who married Luther Hunt, and their son Medad Hunt; being in the family for 131 years. Mr. Joseph Alvord here carried on the business of a weaver and employed a number of hands. His shop was east of his house, nearer to the road and almost on the corner of a street. The old house which he bought of Joseph Clesson, he tore down, and erected a large substantial mansion instead of it. His aunt Abigail, widow of John Alvord (see wife of John Alvord No, 3), resided with him in the old house and a room in the new house was furnished in a superior manner for her.

Tradition says that Mr. Joseph Alvord was so faithful, kind, and attentive to the comforts of his aunt in her advanced age in life (Over 101 years) that it would be an unrighteous act for any one to use him unkindly.

Nathan Clarke of Northampton purchased this homestead about 1865 and moved the house a few rods in the rear, on a cross street and erected a new building, partly on the same foundation.

As you travel from Hadley towards Northampton Court House, you cross the Conn River, after which, about a half mile distant on the right, on the farther corner of the second street on the same road you come to the beautiful site, once the place of residence of Joseph Alvord and some of his descendants, afterwards the residence of Nathan Clark, Esq, Joseph Alvord was a large land-holder and his name appears frequently on the land records. He was constable in 1745.

Joseph Alvord and his wife were buried in the old cemetery at Northampton, and their tomb-stones are still standing (1908).

Mrs. Clemence (Wright) Alvord's grandfather, was Samuel Wright who married Elizabeth Burt and was a soldier on service at Northfield where he was slain by the Indians Sept. 2, 1675.

WILL OF JOSEPH ALVORD

[Copied from Hampshire County Probate Office Court Files. - The Burke and Alvord Memorial]

In the name of God Amen, I Joseph Alvord of Northampton, in the County of Hampshire, in his Majesty's Province of the Massachusetts Bay, in New England, being in health, and of sound mind, and memory; Blessed be God; do this eighth day of Anno Domini, 1774, "make and Publish this my last will and testament, in manner following; that is to say" Principally, I commend my soul to God the Father of Spirits, hoping for pardon, and Gracious acceptance with him, only, on account of the Glorious and perfect Mediator, and atonement, made for miserable sinners by the Lord Jesus Christ; and I desire my body, may be decently interred, at the direction of my Executor, hereafter named, in full faith of the great Christian Doctrine of the Resurrection of the Body; and what followeth is my last will and testament;

As to worldly estate wherewith the Lord has been pleased to bless me; to wit in the first place;

I give, and bequeath, to my beloved wife Clemence, the vse, and improvement, of one half of the Homestead I now live upon, together with the vse, of the one half of my house, and half of the barn, also the improvement of ten acres of my meadow land where she shall please to take it; also the one half of my Inner Common's land; to have, and to hold so long, and for such term of time, as she shall remain the widow of me the Testar, and no longer, also I give & bequeath to my sd wife all my household stuff to her disposal forever.

I give, and devise, to my son Elisha, four acres of my pasture land, being inclosed within the meadow fence under the hill, on the south side of the pasture; also one acre lying on the hill, adjoining the sd four acres; also two acres and three quarters of land lying in the meadow in Venturer's field ;

Also woodland lying in the Long Division, so called that I had of my uncle John Alvord, from the east end of sd lot the North Branch Manham River, to have, and to hold, to him, and his heirs forever.

To my son Joseph I give and devise the homestead he now liveth upon, on the east side of the county Road, that I purchased of Henry Curtis, it being three acres and twenty rods.

Also two acres of land lying in the meadow at the Walnut tree, called Clapp's lot; also one acre and half of land lying in the meadow at the upper end of Young Rain Bow at the Point; also my second draught in the Inner Common land, lying near to Fortification Hill, to have and to hold to him and his heirs for ever.

I give and devise to my son Stephen twenty shillings more than I have already advanced him.

I give and bequeath to my son Medad the homestead I now live upon together with the house and barn and all other buildings standing thereon allowing to my wife the improvement of the one half as above said.

I give and bequeath to my son Medad five acres of land lying in the pasture within the meadow fence on the north side of sd pasture; also five acres and one quarter lying in the Upper Meadow in the Second Division;

Also five acres and one half lying in the old Rainbow, also my lot of land at the Walnut trees containing three acres; also two acres and one half of land, lying at the upper end of Young Rainbow, also all my land in the Long Division that was originally laid out to my Hon. Father Ebenezer Alvord, deceased; from the east end of sd lot running westward, to the north Branch of Manham River, except that part of it which I have conveyed to David Clark by deed of sale:

Also my first draught in the Inner Common land lying on the Boggy Meadow; to have, and to hold, to him and his heirs forever.

I give to my son Simeon ten shillings more than I have already advanced to him in full satisfaction for his part and portion of my estate.

I give to my daughter Lucy Parsons five shillings more than I gave her at her marriage.

The remainder of my estate both real and personal if any there should be after my just debts are paid, I give to my son Medad to be to him and his heirs forever: Lastly I hereby constitute and appoint my son Elisha my sole Executor of this my last will and testament.

In witness whereof I have hereunto set my hand and seal the day and year above written.

Signed, Sealed, Published and Declared by the before named Joseph Alvord the Testator as his last will and testament.

Codicil.

A Codicil to be added to and to be taken as a part of the last will and testament of Mr. Joseph Alvord of Northampton in the county of Hampshire, Yeoman.

Whereas I have made and published in writing bearing date the eight day of November Anno Domini 1774; which will, and the devices, and bequests therein contained were at that time according to my best judgment and discretion; Yet on the account of the decease of my wife, which has happened since that time and diverse other alterations in my circumstances which have since taken place too many here to recite and as it has pleased God not only to continue my life but also my understanding and judgment so that. I am still (Blessed be God) of a sound and disposing mind and memory I do this seventh day of November A. D. 1782 make and publish this Codicil that is to say all the lands and tenements which in and by my above mentioned will, it is declared that I give and devised to my son Elisha Alvord, which I still own, I do hereby give and devise to my three grandsons, and the sons of the said Elisha, to wit; Eleazer Elisha and William, to have and to hold to them in fee simple by equal shares as tenants in common and not as joint tenants on and under the conditions, restrictions limitations and provisoes herein after expressed and declared and not otherwise, that is to say if every and all of my said grandsons should die without issue of his body lawfully begotten and living at the time of the death of the father before he shall attain the age of twenty one years and living, my grandson Daniel Alvord the son of my son Elisha then my will is that he the said Daniel shall take and have in fee simple all the said lands and tenements subject to all conditions and provisions which are herein after provided and declared relating to the taking and holding of the same lands by my said grandsons Eleazer Elisha and William so far as the said conditions or provisions respect any dutie or payments too be made and performed by them to my said son Elisha or his present wife Mary.

And in case of the death of anyone or two of my said grandsons Eleazer Elisha or William, without issue of his body lawfully begotten and living at the time of the death of the father before he shall attain the age of twenty one years, in that case the survivors or the surveyors of the said Eleazer Elisha and William together with him the aforesaid Daniel shall take and hold in fee simple by equal shares as tenants in common and not as joint tenants all the said lands and tenements always subject to the conditions provisoes injunctions directions here expressed and declared respecting the having and holding of the said lands by my said grandsons and any of them the heirs or assigns of any of them

To wit;

That each of my said grandsons, &c., &c., shall annually from the respective times when the said lands shall fall to them, respectively in the life time of my said son Elisha or after his decease, the said Mary his now wife living and being his widow, pay to him my said son Elisha and after his death to his widow aforesaid during such widowhood such and part of the sum of four pounds of the now lawful silver money of this Commonwealth as shall be in proportion to four pounds, &c., &c.

And to my grand daughter Sarah Alvord, the daughter of my son Joseph, I give and bequeath my spare feather bed and bolster and the two rugs belonging to the said bed also three of my pewter plates as good as one with another.

And all the residue of my household stuff, I give and bequeath to my daughter Lucy the wife of Mr. Elisha Parsons forever.

And I do hereby constitute, make & ordain my son Medad Alvord to be joint Executors with my aforesaid son Elisha of my last will and testament, &c., &c.

Noah Alvord settled in 1732 in that part of Springfield which is now Wilbraham, being the second settler, then a wilderness, near Nathaniel Hitchcock, the pioneer who came with his young wife the year before and made his home in a hut by the mountains. "Sweet counsel did these two neighbors take respecting the field to be cleared, to be planted or to be sown; and often did Hitchcock that summer after his neighbor's arrival, take his ax and go over to his neighbor Alvord's to work by his side, softening the hardness of the labor by the pleasure of society. And you might have seen Alvord of an early morning with his hoe in hand, going over to make Hitchcock's long day's work shorter by his helpfulness. Nor was there any rivalry, between wives, except to most lovingly and abundantly render all needed service to each other ,"

Noah Alvord settled on the place where Lorenzo Kibbe resided in 1866. His four children had no children. Mrs, Rebecca Alvord married Oct., 1774, David Burt.

"June 7, 1745, Noah Alvord of Springfield, in the county of Hampshire, blacksmith, for six pounds," conveyed, "to my brother, Joseph Alvord of Northampton, all the lands which I have in Northampton, whether divided or undivided; as I am an heir to my Hon-rd father, Mr Ebenezer Alvord, late of Northampton, deces-d; as also I am an heir to the estate of my grandfather, Mr. Joseph Baker formerly of Northampton, deces-d, both by my Hon-d mother who was the daughter to sd Joseph Baker, and also by my brother Ebenezer Alvord dec-d an heir to the sd Ruth my Honoured mother and grandmother aforesaid.

He was in tax list, 2 polls, 33 est. John Alvord, son of Jonathan, is also mentioned as having his homestead in the Plain, called Ft. Plain. He bought the place of Josiah Searls. In 1730 John Alvord drew a home-lot in Southampton, Mass. He was appointed packer of meat in 1746, 1755, 1766-68. He died at the home of his son John in Easthampton.

The will of John Alvord is on file in the Probate Office at Northampton, Mass, but was never recorded. He mentions sons Zebadiah and John Alvord.

Jonathan Alvord was living on Prospect St. with his brother John (whom see) in 1749 and was in tax lists for 1 poll, 18 est. He was living in Westhampton in 1777 about three miles, west of the center. Joseph Hathaway lived on the place later and the old house is still standing (1908). Jonathan Alvord was about the last person buried in the N. Cemetery by the bridges.
