KNOW ALL MEN BY THESE PRESENTS:

THAT I, JOHN RELAND WALLINGFORD, of Harris County, Texas, being of sound and disposing mind and memory, above the age of nineteen years, and being desirous to settle my worldly affairs while in good health, and while I have the strength of body and mind to do so, do make this my Last Will and Testament, hereby revoking all wills and codicils by me at any time heretofore made.

1.

I desire and direct that my body be buried in a decent Christian like manner, suitable to my circumstances and conditions in life.

2.

I desire and direct that my just debts be paid out of my estate by my Executrix, to be hereinafter named and appointed.

3.

It is my will and desire that all the property, real, personal or mixed, wherever located, that I may own or be interested in at the time of my death shall pass to and vest in fee simple in my beloved wife, CORINNE OGG WALLINGFORD, of Harris County, Texas. And after the payment of my just debts, together with the expenses incident to the probating of this Will, I GIVE, DEVISE and BEQUEATH unto my beloved wife CORINNE OGG WALLINGFORD, the remainder, rest and residue of all my estate, real, personal or mixed, wherever located, that I may own or be interested in at the time of my death, in fee simple, to manage, own, control, sell, or dispose of as she may wish or see proper.

4.

It is my will, and I authorize and empower my said Executrix to be hereinafter named and appointed, or her substitute, to sell, dispose of, deliver and convey, any portion of my estate, real, personal or mixed, at public or private sale, for any price, or on any terms and in any manner that she may desire or see best.

5.

I hereby name, constitute and appoint my beloved wife, CORINNE OGG WALLINGFORD, Sole Independent Executrix of this my Last Will and Testament, and direct that no bond or other security be

required of her as such Executrix.

6.

It is my will, and I direct that no other action shall be had in the County Court in the Administration of my estate than to prove and record this Will, return an Inventory and Appraisement of my estate, and List of Claims.

7.

In the event that my wife, CORINNE OGG WALLINGFORD, and I should die in the same accident, calamity or disaster in such a manner that it cannot be reasonably determined which of us survived the other, or in the event that my beloved wife should predecease me, then in that even or either event, it is my will and desire that after the payment of my just debts, and the expenses of probating this will, all the property, real, personal or mixed, which I may own or be interested in at the time of my death shall pass to and vest in fee simple in JOAN WALLINGFORD MICKLER, of Harris County, Texas, in trust and as trustee for my two (2) minor children, NICHOLAS WALLINGFORD, who was born May 4, 1951, and CARL WAYNE WALLINGFORD, who was born July 15, 1953. My said trustee is herenow authorized to manage and to handle all the properties passing to her hereunder in such manner as in her judgment may seem best, to loan the moneys belonging to the trust estate, to sell and convey the properties of the estate, receive moneys, invest the same, or re-invest the same and to do any and all things necessary for the best interest of the trust estate herenow created. My said trustee is herenow specifically authorized and empowered to use any portion of the principal and income of this trust for the support, maintenance and education of my two (2) minor children that she in her own discretion and judgment may deem necessary and see proper. In administering the trust estate, my trustee shall have all the powers herein granted and all the powers conferred by what is called the Texas Trust Act being Chapter 148, Page 232, Acts 1943, 48th Legislature, and shall be entitled to all the benefits and privileges of said Act, and where not specifically provided herein, shall be governed by the provisions of said Act in the Administration of the trust estate.

When my minor son, CARL WAYNE WALLINGFORD, who was born July 15, 1953, reaches the age of Twenty-one (21) years, my trustee shall, as near as practical, divide the remainder of the trust estate, if any, into five (5) equal portions and shall convey, set aside and turn over to each of my children, named hereinafter, to-wit:

1. JOAN WALLINGFORD MICKLER,
2. JOHN ROLAND WALLINGFORD, II,
3. KAREN WALLINGFORD MOORE,
4. NICHOLAS WALLINGFORD, and
5. CARL WAYNE WALLINGFORD,

and this trust shall end. However, my said trustee shall have a period of two (2) years, if necessary, to sell any of the properties belonging to said estate and make such division, after the date that my son, CARL WAYNE WALLINGFORD, shall become twenty-one (21) years of age. In the administration of the trust estate, the trustee shall be allowed all necessary expenses which she is herenow authorized to pay from any funds belonging to said trust estate, together with five per cent commission, upon all income actually produced by said estate. In rendering a final accounting to my said children, said trustee shall accompany the same with a written statement of all moneys disbursed as expenses and all commissions received by her during the administration of said estate.

The acts of my trustee, or her substitute, in handling any of the properties of the trust estate shall be conclusive and binding upon all persons, and in the absence of intentional fraud shall not be subject to contest by any person interested in said estate.

In the event that such common disaster as set out in paragraph 7 above should occur, then and in that event, I name, constitute and appoint JOAN WALLINGFORD MICKLER, of Harris County, Texas, Sole Independent Executrix of this my Last Will and Testament, and I direct that no bond or other security be required of her as such Executrix, and I further direct that no other action shall be had in the County Court in the Administration of my estate than to prove and record this Will, file an inventory and appraisement of my estate, and a list of claims as provided by law, and I further direct that no bond

or other security shall be required of the said JOAN WALLINGFORD MICKLER, as trustee. I further desire and direct that in the event that such a common disaster should occur as set out in paragraph 7, that the said JOAN WALLINGFORD MICKLER, shall be the Guardian of the Persons and estate of my two (2) minor children hereinabove mentioned without bond.

In the event that the said JOAN WALLINGFORD MICKLER, should be unable to act or refuse to act as Sole Independent Executrix under this Will and Testament, or that she should fail or refuse to act as trustee herein, then I do hereby name, constitute and appoint KAREN WALLINGFORD MOORE, of Harris County, Texas, Sole Independent Executrix herein, and substitute trustee herein, without bond, and the said KAREN WALLINGFORD MOORE shall succeed to all the powers and rights granted herein.
